Considerations such as what you are trying to convey, key dates or timeframes to highlight, or emphasizing *succession* of events, will have an impact on how you layout events, how you effectively use the space of your timeline, and how you choose to emphasize your data points for the clearest understanding, to tell your client's story, and to support your arguments.
