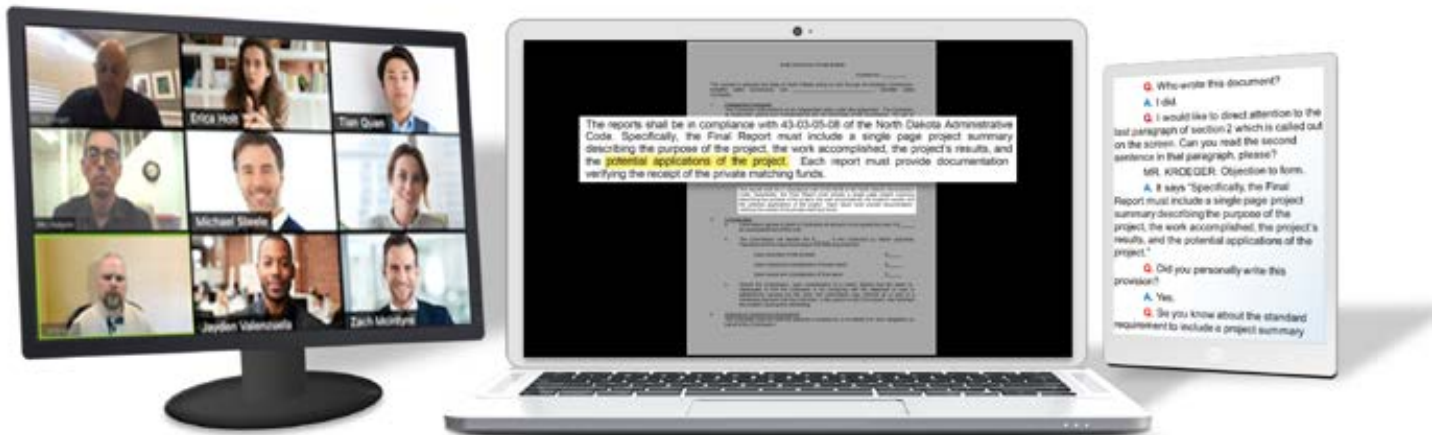

Have video and non-PDF documents pulled up and ready to screen share in full-screen mode.



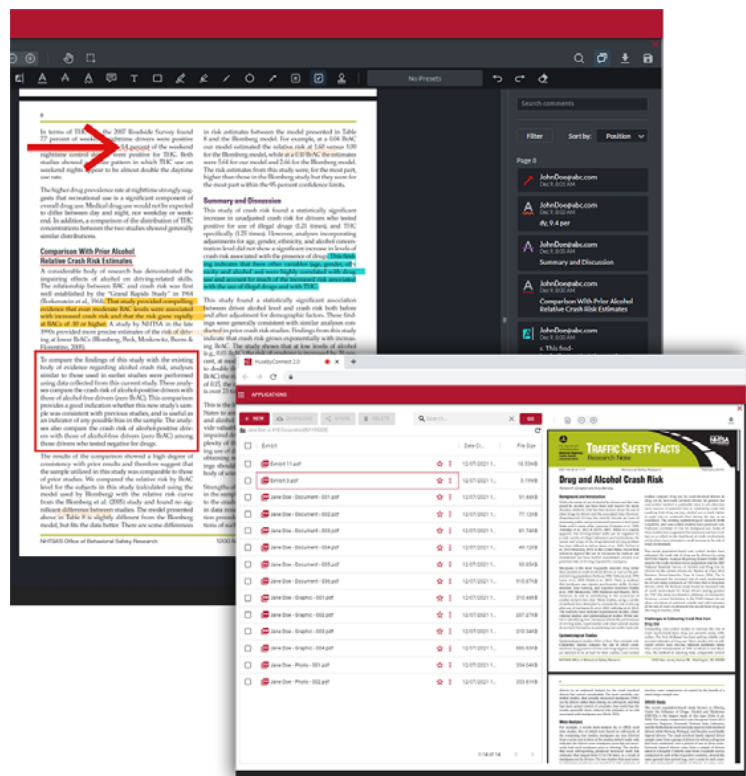
### Exhibit Management
