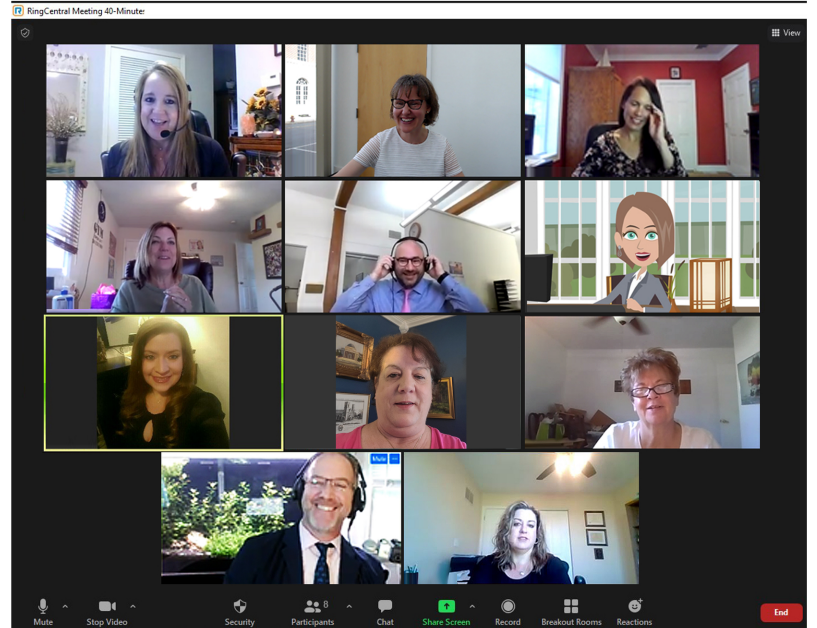

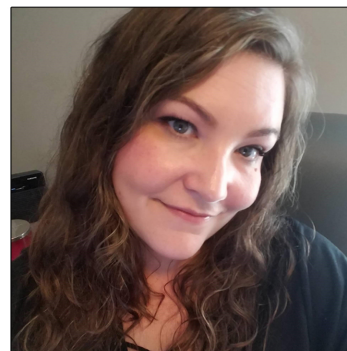
Julianna has hit the ground running as an integral part of Huseby's Scheduling Team.
